## DESCRIPTION

How to make Davis - Bacon work for you!

Receive current information regarding how to include labor standards clauses in your contracts.

The Davis - Bacon Act requires payment of prevailing wages on federally funded or assisted construction projects. Contractors and subcontractors must pay laborers and mechanics employed directly upon the site of the work at least the locally prevailing wages (including fringe benefits), listed in the Davis – Bacon wage determination in the contract, for the work performed.
